No. GH/SH/(8)/SCT/1009/1528/GII:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Lecturer in Diploma in Engineering or Technology in the Government Polytechnics, Class - II, Recruitment Rules, 2009, namely:-

1. These rules may be called the Lecturer in Diploma in Engineering or Technology, in the Government Polytechnics, Class-II, Recruitment (Amendment) Rules, 2011.
2. In the Lecturer in Diploma in Engineering or Technology, in the Government Polytechnics, Class- II, Recruitment Rules, 2009, in rule 3, in sub-rule 2 for clauses (a) and (b), the following shall be substituted, namely:-

“(a) for the post of Lecturer in Engineering or Technology,-

Possess a Bachelor's degree in Engineering or Technology in the relevant branch with first class or equivalent.


provided that if the candidate possesses a Master's degree in Engineering or Technology, first class or equivalent is required either at Bachelor's or Master's level;

(b) for the post of Lecturer in Humanities or Science,-

Possess Master's degree in appropriate subject with first class or equivalent.

Provided that first class or equivalent is required either at Bachelor's or Master's Level”.

1. These rules may be called the Lecturer in Diploma in Engineering or Technology, in the Government Polytechnics, Class-II, Recruitment (Amendment-1) Rules,2009.
2. In the Lecturer in Diploma in Engineering or Technology, in the Government Polytechnics, Class-II, Recruitment Rules, 2009, in rule3, In sub-rule(2), in sub-clause (ii), for the words and figures "minimum 75 %", the words and figures "minimum 75 percentile" shall be substituted.

No.GH/SH/ (29) /SCT-1009-1528-GH :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating the recruitment to the post of Lecturer in Engineering or Technology or Mathematics or Physics or Chemistry or English or Economics or Humanities or Sciences for the diploma courses in the Government Polytechnics, in the Gujarat Educational Service, Class II (Collegiate Branch), under the Directorate of Technical Education, Gujarat State, namely:-

1. These rules may be called the Lecturer in Diploma in Engineering or Technology, in the Government Polytechnics, Class II, Recruitment Rules, 2009.

2. Appointment to the post of Lecturer in Engineering or Technology or Mathematics or Physics or Chemistry or English or Economics or Humanities or Sciences, in the Government Polytechnics, under the Directorate of Technical Education, Gujarat State, shall be made by direct selection.

3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,-

(1) not be more than 35 years of age;

(2)( a) *for the post of Lecturer in Engineering or Technology,-*

(i) possess a post-graduate degree with first class in the appropriate branch of Engineering or Technology , as may be specified by the Government, or

(ii) A bachelor's degree with first class in the appropriate branch of Engineering or Technology or equivalent as may be specified by the Government, obtained from an institution recognised by the All India Council for Technical Education, with valid GATE score, minimum 75% and he/ she shall be required to obtain post- graduate degree in an appropriate branch within five years from the date of his/her appointment . In case of failure to acquire the post- graduate degree within the prescribed time limit, his/her increment shall be stopped until he/she acquires the post- graduate degree.

(b) *for the post of Lecturer in Humanities or Sciences,-*

possess a post- graduate degree with first class, in the appropriate branch of Humanities or Sciences as may be specified by the Government;

(c) the educational qualification prescribed in sub-clauses (a) and (b) shall have been obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognized as such or deemed as a University under section 3 of the University Grants Commission Act, 1956 or possess an equivalent qualification recognized as such by the Government.


(3) possess the basic knowledge of computer application as prescribed in Gujarat Civil Services Classification and recruitment (General) Rules, 1967;

(4) possess adequate knowledge of Gujarati and / or Hindi:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.

4. A candidate appointed by direct selection shall be on probation for a period of two years.
5. The selected candidate shall during his probation period be required to pass the qualifying examination for computer knowledge in accordance with the Gujarat Civil Services Computer Competency Training and Examination Rules, 2005.
6. The selected candidate shall be required to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.
7. The selected candidate shall be required to undergo such training and to pass such examination as may be prescribed by the Government.
8. The selected candidate shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by Government from time to time.
