Constitution of India

No:GH/SH/(9)/SCT/1291/687/GH:-In exercise of the powers conferred by the proviso to article 309 of the Constitution of India the Governor of Gujarat here by makes the following rules to provide for regulating recruitment to the posts of **Librarian** in the Government Polytechnics in the Gujarat Educational Service, Class-III (Non Teaching) namely;

1. These Rules may be called the Librarian at Government Polytechnics in the Gujarat Educational Service, Class-III (non teaching), Recruitment Rules, 1994.
2. Appointment to the post of Librarian in Government Polytechnics in the Gujarat Educational Service, Class-III shall be made by Direct Selection.
3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall:-
 - a. not be less than 21 years of age and more than 30 years of age;
 - (b) POSSESS:-
 - (i) Degree in Arts or Commerce or Sceince of recognised University with first or second Class and post graduate in Library Science of a recognised university with First or Second Class.
 - (ii) a post graduate degree in Arts or Commerce or Sceince of recognised University with first or second Class and a degree in Library Science of a recognised university with First or Second Class or
 - (c) have about one year fulltime experience of working indepenently as a Librarian in Government department or reputed educational institutions or library.
 - (d) Possess adequate knowledge of Gujarati or Hindi or both;

Provided that the upper age limit may be relaxed in favour of candidates possessing exceptionally good qualification or experience or both;

Provided further that the Upper age limit may be relaxed in favour of a candidate who is already in the service of the Govt. of Gujarat, and the candidate belonging to the Scheduled Caste or Scheduled Tribes or Socially and Educationally backward class in accordance with the provisions of the Gujara Civil Service Classification and Recruitment (General) Rules, 1967 and ammended from time to time.

4. The candidate appointed direct selected shall be kept on probation for a period of one year.

5. A selected candidate shall be required to pass the Examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government from time to time.
6. A selected candidate shall have to undergo such training as may be prescribed by the Government from time to time.
7. A selected candidate shall be required to furnish a security and surity bond for such amount and for such period as may be prescribed by the Government from time to time.

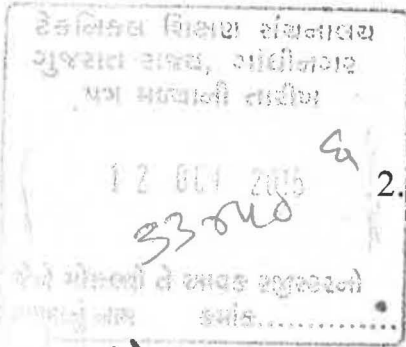

No.:GH/SH/44/2015/SCT/10/2012/109597/GH :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Librarian, Class III, (Non - Teaching) in the Government Polytechnic, in the subordinate service of the Commissionerate of Technical Education, Gujarat state, namely:-

1. These rules may be called Librarian, Class III, (Non - Teaching) in the Government Polytechnic Recruitment Rules, 2015.
2. Appointment to the post of Librarian, Class III, (Non - Teaching) in the Government Polytechnic in the subordinate service of the Commissionerate of Technical Education, Gujarat State shall be made, either -

(a) by promotion of a person of proved merit and efficiency from amongst the persons, who :-

- (i) have worked for not less than five years in the cadre of Cataloguer, Class III (Non Teaching) in the subordinate service of the Commissionerate of Technical Education, Gujarat State; and
- (ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006 :

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two thirds of the period specified in sub-clause (i) above ; or

(b) by direct selection.

3. The appointment by promotion and direct selection shall be made in the ratio of 1:1.

4. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall -

(a) not be more than 32 years of age:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

(b) possess,-

(i) a post-graduate degree in Library and Information Science obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institution recognised as such or declared as deemed University under section 3 of the University Grants Commission Act, 1956 or possess an equivalent qualification recognised by the Government ;

(ii) basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and

(iii) adequate knowledge of Gujarati or Hindi or both.

5. The provisions of rule 9A of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in respect of a candidate appointed by direct selection.
6. The candidate appointed either by direct selection or by promotion shall have to undergo such training and pass such examination as may be prescribed by the Government.
7. The candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
