Schedule of Requirement for Disposal of Old Machine Tools of BBIT

Our institute invites sealed tender marked with **“Bid for the disposal of Old Machine Tools”** for disposing old machines as per attached list of BBIT. These items are to be disposed on **“As is where is” and on “One lot basis”** and on following terms & conditions:

Terms and conditions:

1. All the items to be disposed are stored within the four walls of an enclosed room & you have to bid your price for the whole lot (excluding doors, windows, tube lights & fans mounted in the room) inside the prescribed room.
2. It is advised that, you may visit the institute and physically see the condition of the items to be disposed and accordingly quote the competitive price. For this reason you may visit the institute during the office hours of the institute.
3. You have to quote your price in prescribed format as shown in **Annexure I** attached herewith.
4. You have to bid your price in Indian Rupees strictly for the whole lot.
5. You have to keep the validity of your quoted price for the period of 90 days from the last date of submission of tender.
6. The Tender documents will be available from the B & B Institute of Technology, Vallabh Vidyanagar by Paying Tender fee **Rs. 500/- (Rupees Five Hundred only)** per Tender from.
7. Tender fee **Rs. 500/- (Rupees Five Hundred only)** per Tender to be paid in cash or D. D. in favor of “Charutar Vidya Mandal, Vallabh Vidyanagar” payable at Vallabh Vidyanagar in case the tender document is downloaded from BBIT institute website.
8. Earnest money deposit (EMD) of **Rs. 50,000/- (Rupees Fifty Thousand only)** to be paid through D. D. in favor of “Charutar Vidya Mandal, Vallabh Vidyanagar” payable at Vallabh Vidyanagar, while submitting the tender. **Please keep the draft of EMD & sealed tender document in separate envelope with appropriate marking on top of envelope.**
9. EMD of unsuccessful tenderers will be returned only after completion of disposal process.
10. The selection of firm for the disposal of this lot will be finalized on the basis of highest price quoted by the firm for the whole lot & the decision taken by the Charutar Vidya Mandal, Vallabh Vidyanagar in this regard shall be final & no correspondence will be entertained in this regards in any manner from anyone.
11. Right of negotiation is reserved by the Secretary, Charutar Vidya Mandal.
12. After finalization of selection of firm for the disposal of lot, a sale order will be issued to the selected firm. Selected firm has to deposit **Rs.10000/- (Rupees Ten**

Thousand Only) as security deposit while receiving the sale order. The selected firm has to pay 100% finalized price within 3 days from the date of receipt of sale order. The payment should be made by the way of Demand Draft drawn on any nationalized bank in favor of Charutar Vidya Mandal, payable at Vallabh Vidyanagar. No request for extension of time for payment will be entertained. Delivery order will be issued only after receipt of complete payment. All the unforeseen expenses are in the selected firm's scope including taxes/duties, if applicable.

The security deposit collected from the selected firm shall be for forfeited if the firm fails to deposit the amount as mentioned in sale order within the prescribed time limit or if the firm fails to lift the material before due date or if there is a damage to the property of the institute while lifting the lot by the firm.
